

495 Express Lanes Customer Management


The vast majority of 495 Express Lanes customers use the road properly. In fact, since the road opened nearly 96% of trips on the 495 Express Lanes are tolled, HOV or exempt trips. Approximately 4% of trips are unpaid trips. Transurban's approach to collecting unpaid trips has several steps in order to help travelers avoid high fees. All fees collected are used exclusively to fund enforcement activities.

The Enforcement Process


It's easy for travelers to take care of their toll to avoid escalating fees. There are multiple ways to pay.

Enforcement Process on Tolled Facilities

In order to ensure travelers follow the rules of the road, toll facilities put an enforcement program in place. The 495 Express Lanes program is similar to other tolled facilities in the commonwealth and throughout the United States.

495 Express Lanes is one of a few toll facilities that offers a pre-enforcement payment option via its Missed a Toll website feature.
